Mr. Blanchard introduced this agenda item. Mr. Blanchard explained the 20 STRF claims were submitted by the above named students. The claims were filed for reimbursement of tuition paid directly to Anthem College and Anthem College – Bryman School. Anthem College and Anthem College-Bryman School filed Chapter 11 Bankruptcy on August 25, 2014 and closed the two remaining Arizona campuses to include the on-line campus on

August 29, 2014. The students' claims are eligible as they met the requirements of 1) Arizona residency and 2) were enrolled in the school at the time of closure. It was noted there is no Surety Bond.

Denise Deswood to verify amount of either \$1,120 or \$1,440 and claim Q. Karla Mayoral for verification of cash payment of the \$20.00 application fee.
